ACIDIC DISHWASHER SHINE FOR AUTOMATIC

What is BRIVAL AD?

BRIVAL AD is an additive for automatic inclusion into the final rinse cycle in automatic dishwashers.

PROPERTIES AND USES

Due to its composition it does not foam and dries well leaving a brilliant shine on the washed items.

Thanks to its high concentration BRIVAL AB is very economical using only a small dose to achieve high performance results.

Furthermore its active ingredients reduce the surface tension of the water leaving it to form a uniform film that drains without leaving marks or spots on the surface resulting in a drying time of only a few seconds.

For use in all types of water.

DOSAGE AND METHOD OF USE

For automatic dispensing from 0.1g to 0.3g of product per litre of water, depending on the hardness of the water and the pressure of the rinse.

Contains among other ingredients: amphoteric surfactants (<5%), non-ionic surfactants (5-15%), phosphonates (<5%) and citric acid.
