MULTI-PURPOSE FLOOR CLEANER IN WATER SOLUBLE SINGLE DOSE SACHETS

Concentrated floor cleaner in a single dose water soluble sachet.

USES

For cleaning terrazzo floors, floor tiles, granite, marble, etc. and for any other types of surfaces like wall tiles, sanitary ware, etc.

DOSAGE AND METHOD OF USE

FLOOR CLEANER: Place an unopened single dose sachet into a 7 litre bucket of water and wait for it to dissolve completely.

MULTI-PURPOSE CLEANER: Place one unopened single dose sachet into a 750ml spray bottle with water. Shake to mix evenly.

COMPOSITION

Contains non-ionic surfactants (> 30%), butylphenyl methylpropional, citral, citronellol, d-limonene, geraniol, linalool, perfume and colorant.
