SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, containing flammable substances. Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. A.- Precautions for safe manipulation
